DRIVER REHAB PROGRAM

The driver Rehab Program services are provided by a team of occupational therapy driver rehabilitation specialists and licensed by the PA Department of Education as a Private Driver Training School. Our individually tailored program includes a comprehensive evaluation and may include driver training, with adaptive equipment training when appropriate. All results will be shared with the referring provider and will also be available in your MyChart for your personal access. Printed copies of these reports are only available through our medical records department.

Day of your Evaluation

1. If you are **more than 15 minutes late** to your appointment, you may be required to reschedule your appointment. If you anticipate being late, please call.
2. Bring **current driver's license or permit**, if you have one.
 - Please have a clear understanding of your current license status (i.e. active, suspended, permit only)
3. Bring corrective lenses, if necessary
 - Minimum visual requirement for driving (20/40 distance and 120 degrees of peripheral vision at the horizon)
4. You may **NOT** drive yourself to the evaluations.
 - All participants in the Driver Rehab Program must arrange their own transportation to/from our facility. Any participant that drives to the evaluation on their own, will be asked to arrange alternative transportation or reschedule if necessary.
5. Bring a current list of all medications/supplements taken or prescribed.
6. Bring any paperwork from the Pennsylvania Department of Transportation you may have received.
7. Bring any required mobility aids (e.g. wheelchair, walker, cane), if you currently use one.
8. Be prepared with a form of payment for your evaluation.
 - If payment is through a funding source, OVR or grants, this paperwork process must be requested at time of scheduling and may take up to 4-6 weeks to process. Evaluations cannot be completed until funding is fully approved.

INFORMATION ABOUT THE EVALUATION PROCESS

The driving evaluation consists of a series of interview questions, formal evaluation of your vision, cognition, reaction time, physical status, and a brief assessment of your knowledge of basic traffic signs and road rules.

Driving evaluations do not always move behind the wheel. If the evaluation in the office identifies moderate to high-risk driving, the team will discuss next steps with you.

If identified as appropriate, the driving evaluation will move to behind the wheel. Please note, use of our vehicles is **required** due to the mandate of having a dual-control training brake.

It is the discretion of the provider if the driving portion includes you as a passenger, you as driver on Bryn Mawr Rehab private grounds, or you as a driver progressing to the roadways.

At the conclusion of your evaluation, we will review all relevant findings and discuss any recommendations, including an **estimate** of how many lesson hours you may need when appropriate. The estimate provided is variable, and lessons are based on the client's demonstrated performance. In some cases, an additional appointment may be required to provide clear recommendations. Please note, completing your driver rehab evaluation will not replace your need to complete required State testing to obtain maintain, or restore your license.

FEES FOR DRIVER REHAB SERVICES

Please be advised that the Driver Rehab Program is a **self-pay** program, and **all fees are required at the time of service**. When checking in, we accept credit card payments, personal checks payable to Bryn Mawr Rehab and cash in the form of exact change. In some select cases, funding may be available. All financial statements including last year's taxes and current bank statements must be provided for eligibility. Please contact us directly if you feel you may be eligible. Processing must start 4-6 weeks prior to the scheduled appointment.

Refunds will not be provided regardless of the outcome of the driving evaluation.

- **Driving evaluation (up to 3 hours):** \$450
- **Driving lessons (per hour):** \$150
- **Hourly rate for additional services:** \$150

Where to check-in

As you turn into our grounds from Paoli Pike, continue past the Outpatient Entrance on your left until you reach the Main Entrance at the **back of the hospital**. Please park in Parking Lot B (on your right) or in the accessible parking spaces adjacent to the Main Entrance (on your left). Enter the Main Entrance and proceed down the first hallway on your right (just past the screening station) to the Admissions Department, where you will check-in. Plan to arrive a half hour prior to your evaluation. Arriving early allows for ease of processing in-take paperwork, payment, etc. to ensure your appointment time is not limited by this.

CANCELLATIONS

We understand that unexpected things can happen. If you must cancel, we request that you call 484.596.5000 at least **48 hours** in advance. Participants arriving more than 15 minutes late to scheduled appointments may be asked to reschedule. If you feel unwell or are experiencing any fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea, we kindly request that you call to reschedule.
